## **Health Advisory for COVID-19**

# Dissemination of the San Joaquin County Public Health Services Isolation and Quarantine Orders to Patients with Suspected or Confirmed COVID-19

#### Situation:

- As of June 30, 2020, 3,914 cases of COVID-19, including 54 deaths, have been reported in San Joaquin County residents.
- As the number of COVID-19 cases continues to rise, San Joaquin County Public Health Services (PHS)
  is unable to issue individualized Isolation Orders to cases and Quarantine Orders to their contacts as
  quickly as needed.
- On July 1, 2020, the San Joaquin County Public Health Officer (PHO) issued blanket Isolation Orders
  that will apply to all persons diagnosed with or suspected of having COVID-19, and blanket Quarantine
  Orders that will apply to close contacts of cases.
- Effective July 1, 2020, the PHO directs health care providers and COVID-19 testing centers to
  disseminate these blanket orders to all patients being tested for COVID-19 BEFORE they leave
  the health care facility where they are being tested. For patients with symptoms who are not
  being seen, health care providers are to advise their patients to get the orders from our website

  webpage for your patients.

### **Actions Requested of Clinicians:**

- 1) Direct patients to, or print out and give, the Public Health Officer Isolation and Quarantine Orders and Instructions to all patients confirmed or suspected of having COVID-19. The Orders and Instructions are posted on the Public Health Services website:
  - a) For Providers at http://www.sjcphs.org/Healthcare\_Providers/providers\_landing.aspx
  - b) For Patients at http://www.sjcphs.org/Isolation\_Quarantine.aspx
- 2) Instruct your patients to:
  - a) Self-isolate at home while waiting for the results of COVID-19 testing (if being tested);
  - b) Adhere to the Public Health Officer Order of Isolation and the Home Isolation Instructions if their COVID-19 test results are positive or pending or if you determine that they likely have COVID-19;
  - c) If diagnosed with COVID-19, inform their household members, intimate partners, in-home caregivers and any others they were close to (within 6 feet for 15 minutes or more). They must also provide those individuals with the Health Officer Order of Quarantine and the Home Quarantine Instructions for Close Contacts to Coronavirus Disease 2019 (COVID-19).
